MAHONING COUNTY, OHIO, DIVORCES

1846 - 1887

These early divorces of Mahoning County, Ohio, are recorded in various journals and ledgers. While these books were still stored in the courthouse attic, William T. Powers spent many months carefully abstracting the records. The Appearance Dockets, Chancery Records, Journals, Execution Dockets and Partition/Petition Records were all checked, page by page, and the divorces abstracted for publication in *Mahoning Meanderings*, the Chapter's newsletter.

When the courthouse restoration project was started the various dockets were moved out to the Annex (the old Sears building) in the uptown area. That's when Mr. Powers discovered that a few of the old volumes had been missed when he abstracted these records. They were hidden and 'buried.' This compilation includes those missed records and a new every name index.

At the present time (January, 1993) they are stacked in the hallways of the court house basement. The pages are being cut from the bindings, micro-filmed,¹ then destroyed. Unfortunately they do not have the room to store these old volumes and the local historical society doesn't want them.

The first records of the cases presented here were found in the Execution Dockets, except a few that started in the Appearance Dockets.

Occasionally the handwriting was hard to decipher and left questions about the names. In some cases the ink was faded or the page soiled, making it difficult to be sure we had read the name correctly. Other records, such as census and marriage, were checked and compared and the names as listed here are as close to being correct as possible.

We have given the facts as they were found. Whichever names were first, husband or wife, that person is the plaintiff (the person who initiated the suit).

The marriage dates (when given) may not agree with those in the official record, the family Bible, church records, etc. However, they were copied as recorded. Perhaps the discrepancies can be blamed on the stress of the moment or the poor memory of the persons involved.

Sometimes the maiden name was recorded. This has been shown by 'nee' following her given name, i.e.: Helen nee SMITH. The maiden name has *always* been included in these abstracts, when found.

All children named were included! If their ages and/or birth dates were given those are included also.

Each case was carefully checked for *all* the genealogical data it contained and everything of importance was abstracted. *There is nothing more to be found in the various journals, etc.* Unfortunately, we didn't know the original books were to be microfilmed, then destroyed. So, the citations are to the original records, books, etc. It will still be possible to obtain a copy of the original entries off the microfilm.

MAHONING COUNTY, OHIO, DIVORCES
1846-1887

People sometimes have the mistaken idea that divorce was unheard of in the 'old days.' This is not true and divorces have been recorded since this country was founded. If you have 'lost' an ancestor or ancestress in Mahoning County, they may appear in these records.

These records were first published in *Mahoning Meanderings*, the newsletter of The Mahoning County Chapter, of the Ohio Genealogical Society. They were published in two page sections over a two year period. These sections have been combined and an *every name* index added.

This revised version of the divorce records contains those divorces that were inadvertently omitted when the original work was done. Late last fall (1994) another journal was discovered in the courthouse attic. This journal contained a few divorces, which were abstracted and added to the previous compilation. A new every name index was also done.

Each case has been presented in the following manner: (naturally there are exceptions). Name of plaintiff, name of defendant and the type of petition, i.e. divorce (div), divorce and alimony (d/a) or alimony (al).

Date of petition and date of marriage *if given*.

Information such as: children [their ages and/or birth dates *if given*], cause of petition, testimony, etc., etc.

Citations of the sources and result of the suit, *if given*.
