These records were abstracted from Guardian's Docket No. 1, Mahoning County, Ohio Probate Court. The old book is in the basement of the courthouse. It's soiled and many pages are faded. Sometimes entries were almost illegible, but every attempt was made to decipher the old handwriting and present the names, dates and places as they appeared.

The records are given as follows: Name; age and/or birthdate; child or children of; guardian; Bond: amount; Sureties: Guarantors of the bond. Some records contain more information, some less. Each name, date and place mentioned was abstracted for this compilation.

If a minor is called an "orphan," it didn't always mean both his/her parents were deceased. Sometimes the surviving parent is named the guardian when the children are called orphans.
